Set 12 external swellable casing packers for isolation of production string at the following depths: (1) 9709' (2) 9367' (3) 9022' (4) 8717' (5) 8375' (6) 8029' (7) 7670' (8) 7322' (9) 6979' (10) 6774' (11) 6330' (12) 5947'.
