Set 20" 94# conductor 11/19/13. Set depth: 74'. 100sks Type I Neat cement mixed at 16ppg.

Well spudded 11/22/13.

Set surface casing and cemented 11/22/13. Gelled freshwater mud system.

Hole diameter: 12.25", casing diameter: 9.625", casing weight and grade: 36ppf J55 LTC. Depth of 12.25" from 0-522'TVD/MD. Casing set from surface to 519'TVD/MD.

On 11/23/13 pumped 185sks Type III Cement +1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A. Yield 1.38 cuft/sk. Mixed at 14.6 ppg. 18bbls circ, to surface. WOC 9.5 hours for surface casing.

Float collar at 475'TVD/MD. TOC at surface and BOC at 519'.

Tested BOP 11/23/13 to 3000# for 30 minutes. No pressure drop. Tested casing 11/23/13 to 1500# for 30 minutes. No pressure drop.

Started drilling out float collar (tagged at 454') on 11/24/13.
