3. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. The referenced well was shut in during March 2004 due to the closure of the helium plant that processed the produced gas stream. The ownership of the helium plant has changed and is now under new management. The plant is currently being repaired and upgraded. Recommissioning should take approximately three months. The plant and helium wells should be brought back on-line during the First Quarter 2006.

It is respectfully requested that the deadline for permanent abandonment of the referenced well be extended to September 30, 2006 to allow for the recommissioning of the helium plant. The well is currently completed in a manner that does not pose environmental concern. Should conditions change, the well will be permanently abandoned as soon as possible.
