

Perform MIT test on the casing, 4. Run CBL logs, 5. Perforate MV intervals (5004' - 5182'), 6. Fracture stimulate the Mesa Verde stage 1 intervals via 3 1/2" N-80 frac string, 7. Perforate and fracture stimulate the stage 2 MV intervals (4680'-4842' via 3 1/2" frac string. 8. Evaluate MV intervals, 9. Remove frac string, CBP and return well to production as a MV / Dak dual producer. Well may be comingled DH (with R-11363) or surface comingle pending appropriate NMOCD approval (documentation would be provided).**
