

Merrion Oil & Gas would like to set a CICR @ 4810' KB to isolate the producing interval. The tbg will be run back in the hole and the well will be shut in. Fluid level will be measured one week following the shut in and the fluid level in the well will be monitored monthly thereafter to ensure no cross-flow occurs. Fluid level data will be submitted to the NMOCD Aztec office. Merrion will evaluate economics with the intent of plugging the well in the summer of 2014.
