- 2) Weld steel plate on top of 7" 20# surface casing and around 2-7/8" production casing and seal surface casing off.
- 3) Install bradenhead valve on the 7" surface casing.
- 4) Schedule bradenhead test and notify NMOCD to witness test.
- 5) Work to be completed by February 7, 2014.
