Set 13 external swellable casing packers for isolation of production string at the following depths: (1) 10149' (2) 9849' (3) 9504' (4) 9168' (5) 8815' (6) 8475' (7) 8173' (8) 7830' (9) 7485' (10) 7141' (11) 6798' (12) 6497' (13) 6160'.
