Chevron would like to downhole commingle production from the Largo Gallup Gas Pool with existing Blanco Mesaverde and Basin Dakota production in the Rincon 186M well. Currently this well is operating with DHC 1176.

Commingle of the zones should not reduce the total remaining production value of this well. Chevron plans to use the incremental allocation method to account for the additional production from the Largo Gallup. Any additional production to the current production will be attributed to the Largo Gallup.
