In reference to the unlined permanent pit (UPP) at the Riddle F LS 8 location, a closure plan was submitted to the NMOCD Santa Fe and accepted. The UPP was sampled and those samples analyzed in accordance with the standards set forth in the closure plan. All laboratory analysis returned with levels less than the criteria set forth in the NMAC. The UPP was backfilled with clean material and the area will be reclaimed along with the entire plugged and abandoned gas well location. In accordance with the closure plan application submitted, a completed C-144 will be sent to the NMOCD with supporting documentation. The FFO BLM has the laboratory analysis on file and the UPP is ready for reclamation.
