Set 11 external swellable casing packers for isolation of production string at the following depths: (1) 8866' (2) 8154' (3) 7441' (4) 7181' (5) 6962' (6) 6703' (7) 6484' (8) 6266' (9) 6048' (10) 5829' (11) 5567'.
