The well has been shut-in since November 2011 due to low gas prices and high water disposal costs. The last production was near 65 mcf/d and 110 bwpd. Although gas prices have come up in previous months and the well is capable of production, economic production is still not viable. We request continued shut-in and "ready-to-run" status with annual approval pending economic improvement in order to recover the remaining reserves. The location and well are monitored and managed to conserve the investment, the resources in the reservoir and on the surface.
