03/19/14 MIRU Mote. Drill 12-1/4" hole to 337'. Discovered wellhead marker had been moved approximately 20' to the east to accommodate rig anchors. Stopped operations. Called in Vector Surveying, confirmed hole placement would make well NSL (Legals: 337' FNL & 311' FEL, 36.248101N, 107.696812W). Received verbal approvals from Jim Lovato (BLM) and Brandon Powell (OCD) to cement this hole, respot rig to the correct wellhead marker and proceed with correct spud.

Mote ran in hole with 1" poly reel to 337', pump & fill hole with 203sx (59bbbls) Type III cement w/20% flyash. Top out to surface. Place 1" steel plate over hole, cover up. Witnessed by Bills Diers (BLM)
