13. Describe Proposed or Completed Operation: Clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. 5/6/14 - MOL, RU, SICIP - 245 PSI, SITP 155 PSI; blow down well, kill well, NU BOP, TOH with 2-3/8" tubing (3475'). TIH with mill.

5/7/14 - SICIP 240 PSI; blow down, kill well; TOH with string mill; TIH with tubing and set RBP at 3350'. Observed gas bubbling outside 5-1/2" casing in wellhead, appears there is no secondary seal in wellhead present.

5/8/14 - SICIP 15 PSI, SITP 15 PSI and SIBH 15 PSI; blow down all; bradenhead remains with a constant small blow; pressure test casing to 880 PSI, held good for 30 minutes; TOH with tubing. Ran CBL and found TOC at 2040'. Decide to change out wellhead.

5/9/14 - SICIP or SITP - zero; Bradenehad vented to pit overnight. ND BOP; remove tubing head; install new tubing head that does have secondary seal assembly; NU BOP; Pressure test 5-1/2" casing on chart to 580 PSI, held OK; TIH with retrieving head; prepare to swab.

5/12/14 - Swab out 53 bbls; release and recover RBP; land well with 110 joints 2-3/8" tubing at 3931' with seating nipple 1 joint off bottom at 3401'. ND BOP. NU wellhead. Return well to production.

Plan to vent bradenhead to steel tank and will conduct a 24 hours bradenhead shut in pressure monthly until it disapates. The bradenhead 24 hour pressure will be reported monthly on a Sundry Notice.
