The SHL was adjusted due to a misinterpretation of the well pad plat that resulted in drilling the Good Times P36A-2410 01H well from the Good Times P36A-2410 03H wellhead location. Due to this error, Encana moved forward with drilling the Good Times P36A-2410 03H from the 01H location and is requesting this change.




