6/28/14 - RIH w/ 2 7/8" tbg and tagged top of CIBP @ 5524'. RU Halliburton Cement Crew. First cement plug from 5404'-5524': pumped 16 sx cement, displaced with 31 bbls of water, POOH 13 jts and reversed out 40 bbls. Spot EOT @ 4535' to prep for 2nd cement plug. Second cement plug from 4415'-4535': pumped 22.4 sx cement, displaced with 25.5 bbls of water, POOH 6 jts and reversed out 40 bbls. POOH 2 7/8" tbg to PU CIBP. RIH w/ 2 7/8" tbg and set CIBP @ 4303'. Third cement plug from 4253'-4303': pumped 9 sx cement, displaced with 25 bbls of water, POOH 6 jts and reversed out 30 bbls. RD Halliburton cement crew. POOH 2 7/8" tbg. Secure well and shut down.

6/29/14 - RD Basic 1576.

7/3/14 - Lybrook H26-2307 02H Sidetrack spud.

7/4/14 - Tag cement @ 4221', PBTD @ 4261'. Set Whipstock @ 4261'. Mill window from 4256' to 4247'.
