1. Pull the 2 7/8 injection string.
2. Clean out any fill in the well using a 2 3/8 workstring.
3. Acidize the perforations.
4. Fracture stimulate the injection zone (Point Lookout) down the 7" casing.
5. Clean out any fill in the well.
6. Run the injection string back in the hole as originally equipped.
7. Run MIT on 7" casing.
8. Resume injection operations.


