Pumped 5 bbls of PreFlush @ 8.34 ppg, mixed 353 sks of Class G Neat @ 15.8 ppg, yield 1.15 ft/sk, 5.0 Gal./sk, 5 bbls back to surface. Monitored wellbore after pumping, cement did not fall back. Installed Nigh Cap. ✓
