We are submitting this sundry and corresponding plat package to change the well name from the Escrito L27-2409 01H to the Nageezi Unit L27-2409 01H.

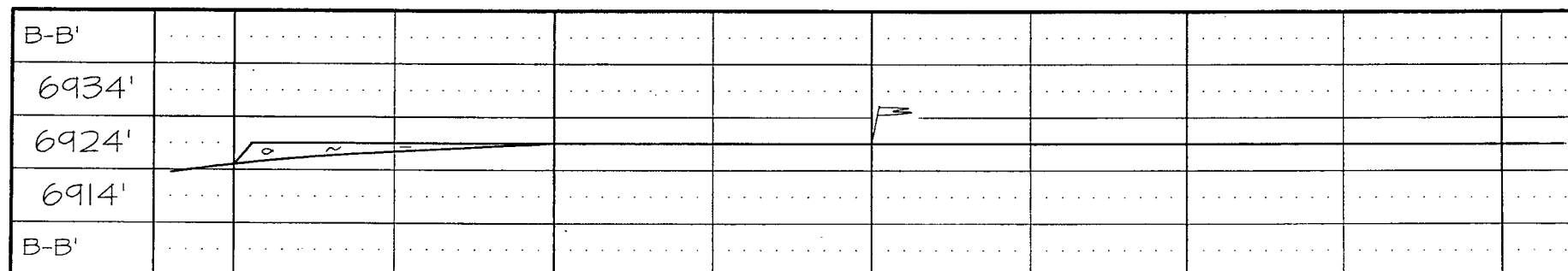
