From the intersection of US Hwy 550 & US Hwy 64 in Bloomfield, NM, travel Southerly on US Hwy 550 for 31.7 miles to Mile Marker 119.5;

Go right (South-westerly) for 0.4 miles to 4-way intersection;

Go straight (South-westerly) @ 4-way intersection for 0.1 miles to Nageezi Unit D34-2409 01H well access road on left-hand side of existing roadway which continues for 10,256.3' to fork in well access road;

Go straight (South-easterly) along Nageezi Unit D34-2409 01H well access road for an additional 1454.3' to fork in well access road;

Go left (North-easterly) for an additional 585.5' to staked Encana Nageezi Unit M27-2409 01H location.
