We are submitting this sundry and corresponding plat package to change the well name from the Escrito L27-2409 02H to the Nageezi Unit L27-2409 02H.

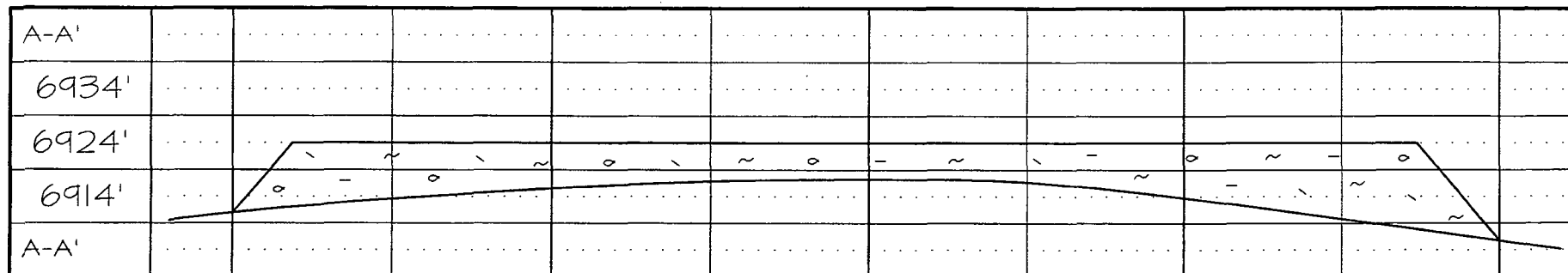
Steel T-Posts have been set to define the Edge of Disturbance limits which are 50' offset from the edge of the staked wellpad.

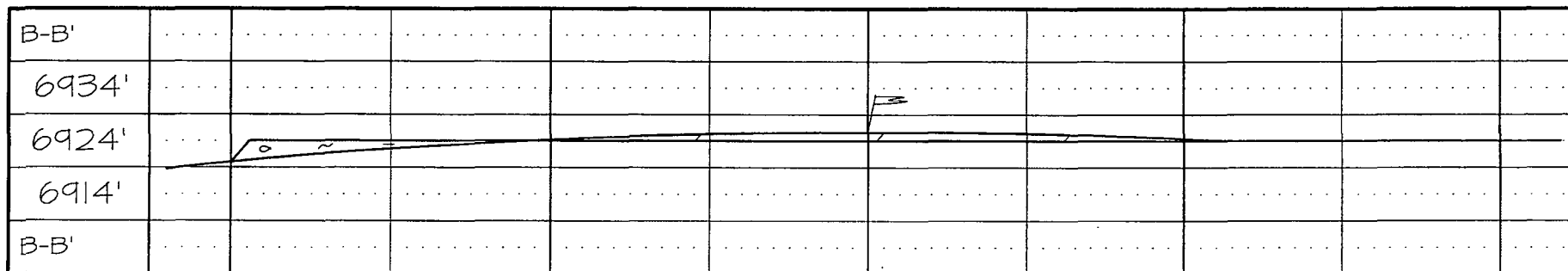
