WPX Energy requests authorization to flare this well due to an expected spike in nitrogen content due to crossflow from frac activity. On or about 10/1/14 frac activity began on the Chaco 2307-12L #171H. This activity is expected to cease on 10/4/14. WPX is planning to flare on or around 10/1/14 until or prior to 11/1/2014.

The Chaco 2307-12E #169H has an average volume of 460 MCF/D and 130 bbls of oil per day. Gas will flow to Beeline Gas Systems, Sec 12, T23N, R07W, given an acceptable nitrogen content of 20% or less. We should see pipeline quality gas by 11/1/14. A gas analysis conducted by a 3rd party will be submitted upon the acquisition of the results.
