WPX Energy requests authorization to flare this well due to an expected spike in nitrogen content due to crossflow from frac activity. On or about 10/4/14 frac activity is expected to begin on the Chaco 2306-18M #240H, 2306-18M #256H, and 2306-18M #292H. This activity is expected to cease on 10/8/14. WPX is planning to flare on or around 10/10/14 until or prior to 11/1/2014.

The Chaco 2306-19E #188H has an average volume of 1115 MCF/D and 530 bbls of oil per day. Gas will flow to WPX Chaco Trunk 3, Sec 19, T23N, R06W, given an acceptable BTU of 870 or greater. We should see pipeline quality gas by 11/1/14. A gas analysis conducted by a 3rd party will be submitted upon the acquisition of the results.
