Tail cmt 354 sx Type II Cmt (14.6 ppg, 87 bbls). Drop plug on the fly, displace w/256 bbls water. Did not bump plug. Pump 1 bbl over displacement. Circ 40 bbls cmt to surface. 15 centralizers.
