It is intended to remove the packer above the **Basin DK** (Pool Code 71599) and commingle with the existing **Blanco Mesaverde** (Pool Code 71599). This production will be commingled according to Oil Conservation Division Order R-11363. Allocation and methodology will be provided after the well is completed. Commingling will not reduce the value of the production. The Bureau of Land Management has been notified in writing of this application.

Perforations are: MV - 3169' - 5624'; DK - 7244' - 7519'. **These perforations are in MD.**

Burlington Resources will use some form of the subtraction method to establish an allocation for commingled wells.
