The F-117 failed its MIT test about 6 months ago. The rig will be moving on this well next week to pull the well and install new tubing, packer set in the range of 816- 916 ft. A new wellhead will be installed. The goal is to have the well complete and MIT'd by September 3rd, weather permitting.
