Plug and Abandonment Summary:

7/23/14 Rode cement equipment to location. Spot in and RU. Open up well; no pressures. Dig out plumb in bradenhead valve. RU 4-1/2" casing head. Blow well down. Pump 15 bbls of water down well. Drop 30 frac balls down well. Pump 15 bbls of water down well. Pressured up to 400 PSI. Spot plug #1 with 117 sxs (138.06 cf) Class B cement pump 10 sxs drop 30 frac balls, pump additional 107 sxs locked up at 500 PSI. SI well. MOL. RU A-Plus wireline. RIH with 3-1/8" HSC and tag TOC high at 55'. POH. Note: J. Hagstorm, BLM and Max Webb approved to use poly pipe. Dig out wellhead. Chip out cement. SI well. SDFD. ✓

7/24/14 Travel to location. Fill out Hot Work Permit. Monitor well for LEL, no LEL. Cut off wellhead. Tag TOC in 4-1/2" casing at 55', unknown in 8-5/8" casing. Run poly pipe 100' down 8-5/8" casing. Spot plug #2 with 46 sxs (54.28 cf) Class B cement top off with 1" poly pipe down 100' in 8-5/8" casing and install P&A marker. RD and MOL. ✓
