Pumped 247 sacks of Type III Halcem Cement + 2% bwoc CaCl + 0.125 lbs/sk Poly-E-Flake, yield 1.17 cuft/sk, mixed at 15.8 ppg on 9/17/14. Circulated 27 bbls to surface. WOC 8.5 hours for surface casing.

Float collar at 494'. TOC at surface and BOC at 538'. ✓

Tested BOP 9/17/14 to 3000# for 30 minutes. Tested casing 9/17/14 to 1500# for 30 minutes. No pressure drop. ✓

Drilled out cement and float collar 9/18/14.
