WPX Energy requests authorization to flare this well due to an expected spike in nitrogen content of over 20% due to crossflow from frac activity on the Chaco 2306-18M well pad for the #240H, #256H, and #292H wells. On 10/4/14, frac activity began on these wells. This activity is expected to cease on 10/22/14. WPX is planning to flare on or around 10/24/14 until or prior to 11/17/2014.

The Chaco 2306-131 #203H has an average volume of 1,923 MCF/D and 390 bbls of oil per day. Gas will flow to Enterprise Systems given an acceptable nitrogen content of 20% or less. We should see pipeline quality gas by 11/17/14. A gas analysis conducted by a 3rd party and results will be submitted upon receipt.
