Well was plugged & abandoned as per the following procedure. Bill Diers with the BLM witnessed job.

- 1) Establish rate w/15 bbls water down 2-7/8" casing.
- 2) Mix & pump 77 sx (91 cu ft, 15.6#, 1.18 cu ft/sx) Class B neat cement from surface down the casing. Locked up. Pressured up to 1250 psi.
- 3) Wait on cement 4 hours.
- 4) Cut wellhead. Tag top of cement at surface.
- 5) Install dry hole marker and fill up w/13 sx (15.34 cu ft) Class B neat cement.
