WPX Energy requests authorization to flare this well for 30 additional days due to the inability to flow the gas through a pipeline. WPX anticipates for the pipeline to be constructed by 2/10/15. WPX will not have completed construction by the time the initial flare approval expires (1/11/15). We are currently waiting for ROW approval from the BLM. As a result, WPX is requesting flare authorization for this well until the anticipated date of pipeline completion.
