HPOC, LLC plans to move-in a workover rig over the Torreon Wash 36 State #1 well and commence operations on Monday, Dec. 15, 2014, weather conditions permitting.

OPERATIONAL PLAN, DECEMBER 2014. Pull ESP, perforate from 5,493' KB to 5,503' KB (on open-hole logs), stimulate these perms with 10' GasGun, swab to establish fluid entry rate, re-run ESP and production test. The goal of these operations is to establish a minimum of 500 barrels fluid per day entry rate when pumping from approximately 2,800'. There is no fluid entry from the original 1' of perforations from 5,504.5' to 5,505.5' due to formation damage from drilling and liner cementing operations.

Once production is established, a C-105 Completion Report will be filed.
