1/3/15 - Notified Agencies, Troy Salyers @ BLM and Brandon Powell @ NMOCD - Ran 7" intermediate casing, pumped cement - cement did not return to surface. Propose to run CBL on Sunday 1/4 to determine TOC. Verbal approval received from both Agencies.

1/4/15 - Ran CBL, forwarded CBL results to Agencies, Troy Salyers @ BLM and Brandon Powell @ NMOCD. CBL shows minimal cement behind pipe. Plan to re-run cement on 1/5 after allowing cement to set longer.

1/5/15 - Ran new CBL, forwarded CBL result to Agencies, Troy Salyers @ BLM & Brandon Powell @ NMOCD. CBL still shows minimal cement behind pipe, with approx TOC @ ~ 3100'. Propose to perf @ ~3020' to 3030', pump cement and establish circulation with cement to surface. We will run another CBL under pressure before commencing remedial cement work. Received verbal approval from Troy Salyers with BLM and Brandon Powell with NMOCD. Both requested to be contacted if we are unable to circulate to surface.

Troy Salyers requested an NOI for the plan forward.
