Tail Cement pumped 11/23/14: 370 sks Type III Cement + 1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A, yield 1.38 cuft/sk, mixed at 14.6 ppg. 65bbbls cement to surface. WOC 5.5 hours.

Tested BOP 11/24/14 to 3000# for 30minutes. No pressure drop. Tested casing 11/24/14 to 1500# for 30 minutes. No pressure drop. ✓
