

Elm Ridge Exploration Co LLC spud the above referenced well on 1-8-15. On 1-9-15 we drilled a 12 1/4" hole to 572' and ran 13 joints of 8-5/8" 24# J-55 casing to 567'. We then pumped 316 sks of Premium Class G cement. Circulated 30 bbls of good cement to surface. Pressure tested casing to 600 PSI for 30 minutes. Test was good. Tested BOP at 2000 PSI for 10 minutes.
