Lead Cement pumped 11/12/14: 481 sks Premium Lite FM + 3% CaCl2 + 0.25#/sk Celloflako + 5#/sk LCM-1 + 8% Bentonite + 0.4% FL-52A + 0.4% Sodium Metasilicate, mixed at 12.1 ppg, yield 2.13 cuft/sk.

Tail Cement pumped 11/12/14: 367 sks Type III Cement + 1% bwoc CaCl + 0.25 lbs/sk cello flake + 0.2% bwoc FL-52A, yield 1.38 cuft/sk, mixed at 14.6 ppg. 40 bbls circulated to surface. WOC 6.5 hours.

Tested BOP 11/13/14 to 3000# for 30 minutes. No pressure drop. Tested casing 11/13/14 to 1500# for 30 minutes. No pressure drop.


