



Pumped 247 sacks of Type III Halcem Cement + 2% bwoc CaCl + 0.125 lbs/sk Poly-E-Flake, yield 1.17 cuft/sk, mixed at 15.8 ppg on 11/22/14. Circulated 20bbls to surface. WOC 7.0 hours for surface casing!

Float collar at 483'. TOC at surface and BOC at 526'. ✓

Tested BOP 11/23/14 to 3000# for 30minutes. No pressure drop. Tested casing 11/23/14 to 1500# for 30 minutes. No pressure drop. ✓

Started drilling out cement at 480'TVD/MD on 11/23/14.
