APPLICATION FOR EXCEPTION TO NO-FLARE RULE 19.15.18.12


B. Based upon oil production of 35 barrels per day, the estimated volume of gas to be flared is 300 MCF/D; Value: \$900 per day.

C. Name and location of nearest gas gathering facility:

Chaco Trunk 4-1 CDP, Sec 13, T23N, R07W

D. Distance BUILT Estimated cost of connection

E. This exception is requested for the following reasons: WPX Energy requests authorization to flare this well due to a high nitrogen content above acceptable Williams Field Service pipeline standards due to nearby frac activity on the NE CHACO COM #166H, NE CHACO COM #167H, scheduled to occur on 3/2/15. As a result, WPX Energy is anticipating that the NE CHACO COM #175H may experience crossflow. If the well experiences crossflow from the stimulation activity, a gas sample will be collected and sent to a third party for a gas analysis to determine the nitrogen content of the well. If the well needs to flare, the results of the gas analysis will be submitted upon receipt. The well could begin flaring as soon as 3/2/15 and flare for up to 30 days if given approval. Pipeline quality gas should be obtained within 30 days of flaring. If the well does not need to flare within the time of approval, a sundry will be written to clarify that WPX did not need to flare the well.
