Set 16 external swellable casing packers for isolation of production string at the following depths: (1) 10226' (2) 9958' (3) 9692' (4) 9424' (5) 9157' (6) 8895' (7) 8636' (8) 8367' (9) 8094' (10) 7834' (11) 7574' (12) 7310' (13) 7053' (14) 6789' (15) 6523' (16) 6258'.
