Pumped 75sxs (122cu-22bbls) Type 1-2 Portland cement w/20% fly ash @ 14.5pps. Drop plug and pump 14bbls H2O w/rig pump to displace cement. Circulated 4bbls. WOC. Install wellhead. Pressure test will be conducted by the drilling rig and will be shown on next report. Rig down and move out.
