TIH with 3-7/8" bit, bit sub, 4-1/2" csg scraper, two 3-1/8" DC and 20 and 1/2 jts new 2-3/8" work string tbg to plug @ 736.60' KB. Circ hole clean. On 4/22/2015, run GR/CCL/CBL logs from PBTD 729' KB to surface. Perf FT coals with 3-1/8" csg gun, 4 spf, 120 degree phasing, shot intervals 644-660' KB, total of 64 holes. On 5/1/2015 acidize and frac as follows: Pumped 500 gal 15% acid, pumped 26,407 gal Delta 140-20# w/SWAT frac fluid; pumped 646.2 sx 20/40 PR w/max BH sand concentration of 5.4 lb/gal. Pumped coated 646.2 sx 20/40 PR with SW-max @ concentration of 2.0 gal/mlbs starting @ the 1# treatment sand stage, pumped 490 gal wtr frac G & 26,407 gal of Delta 140A 20%. Avg rate 23 BPM @ avg WHTP 615 psi. ND HES, secured location on 5/1/2015.

Operator will clean out and run pump and tbg the latter part of May, 2015.
