XTO Energy Inc. is providing a status update on this well due to no production since June 2011. In the status update letter dated May 29, 2013, XTO stated that if we had not RWTP by December 2013 we would update our plans at that time. Status update letter dated January 30, 2014, indicated that, XTO Energy Inc. has determined to plug and abandon this well and will submit a Notice of Intent to Plug and Abandon as soon as we can come to an agreement with the landowner and receive all necessary approvals. As of January 28, 2015 XTO Energy Inc. has reached an agreement with the landowner, and is currently in the planning stages to rebuild the road to this location. XTO Energy Inc. anticipates the road project will be completed by early April 2015, and plans to begin P&A operations as soon as road construction is complete. P&A approval from NMOCD has been obtained.
