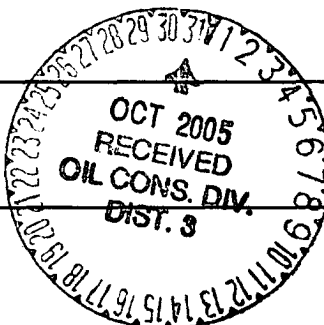

Circ. hole. 9/30/05 RIH w/9-1/2" underreamer and underreamed from 3150' to 3506'. Circ. hole. Started natural and energized surges for approx. 12 days. 10/10/05 RIH & C/O fill w/air & mist. TOOH. RIH w/5-1/2" 15.5# K-55 (12 jts) pre-perf'd liner & washed down to 3502'. TOL @ 3124' (22' overlap). POOH. RIH w/mill and milled out perf plugs from 3208' - 3337' and 3394' - 3415 approx 149 holes.
