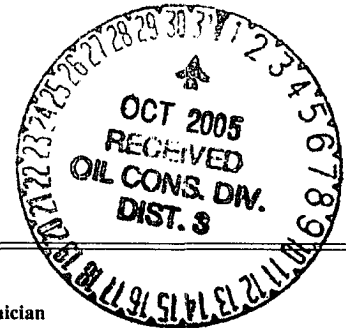

**Drilled 6 1/4" hole to 3,670' on 8/15/05, set 86 jts 4 1/2", J-55, LT&C, 11.6# casing at 3,656'. Cemented lead w/375 sx (98 bbls) 50/50 POZ w/2% Gel, 2/10% Veraset, 1/10% Diacel LWL and tail w/75 sx (19 bbls) 50/50 POZ, 3% Gel, 1 4/105 Halad 9, 1/10% CFR3, 5# Gilsonite & 1/4# Flocele. Indication of cement to surface, top of 50/50 POZ at 3,190' & top of foam cement at 1,010'. Landed 2 3/8" production tubing at 3,462'.**
