Cement with 225 sks Class B, 2% CaCl2, 1/4#/sk flocele (266 cu.ft.). Plug down @ 8:00 am on 10/20/05. Circulate 10 bbls cement to surface. WOC. RD Halliburton. NU BOP. Test casing & BOP to 600 psi - ok.
