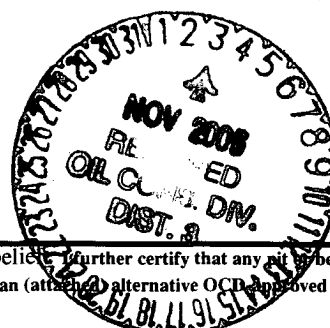

Based on Burlington's interpretation of the Ecosphere's risk ranking criteria, the workover pit will be a lined pit as detailed in Burlington's Revised Drilling / Workover Pit Construction / Operation Procedures dated November 11, 2004 on file at the NMOCD office. Burlington Resources anticipates closing the pit according to the Drilling / Workover Pit Closure Procedure dated August 2, 2004 on file at the NMOCD office.

On this workover, a vent/flare pit may be the only pit that will be required. Under this circumstance, a portion of this vent/flare pit will be designed to manage fluids, and that portion will be lined, as per the risk ranking criteria.
