10/28/05 drilled 8 3/4" hole to 2918'. 10/29/05 ran 7" 23#, J-55 casing, landed @ 2908' KB (KB=5.0). Pump lead cement 406 sks Premium Lite FM cement, plus 3% CaCl, plus 0.25 lb/sk Celloflake, plus 5 lb/sk LCM-1, plus 0.4% FL-52, plus 8% Bentonite, plus 0.4% Sodium Metasilicate, yield 2.13, 864.78 cu.ft. Tail cement 92 sks Type III cement plus 1% CaCl, plus 0.25 lb/sk Celloflake, plus 0.2% FL-52, yield 1.38, 126.96 cu. ft. We used centralizers every other joint above the shoe to the turbolizers. Ran 1 turbolizer at the base of the Ojo, and 1 turbolizer 1 joint up in the Ojo. Then centralizers every 4th jt to the surface pipe. Circulated 25 bbls of good cement to surface. Shut-in waiting on completion rig.
