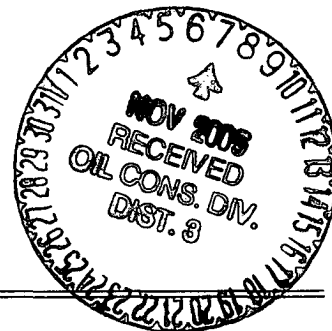

10/25/05 Spud well. Drilled 12 1/4" hole to 425', ran 9 5/8", 36#, J-55 STC casing, landed @ 413' KB (KB=5.0'). On 10/26/05 Cemented with 298 sks Type III cement plus 3% CaCl, plus 0.25 lb/sk Celloflake, yield 1.38, 433.24 cu. ft. We ran centralizers on all joints. Circulated 28 BBLs good cement to surface. Wait on Cement 8 hours. 10/27/05 Tested BOPs 250# low and 2000# high for 10 minutes each. Tested 9 5/8" casing to 600# for 30 minutes, held O.K. Tagged cement @ 335'.
