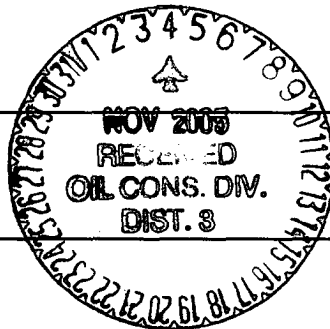

Pumped 11sxs(28cu-5bbls)scavenger cement w/20% flyash. Tail in w/103sxs(135cu-24bbls)Type 3 cement w/3%CaCl2, .25pps Cell-o-Flake. Drop plug and displaced w/9bbls H2O. Plug Down @2018hrs. Circulated 9bbls of cement to reserve pit. WOC. Install wellhead. NU BOP. PT csg to 600psi 30 mins, ok.
