11/05/05 Rig up and test 7" casing pressured up to 1500# for 30 minutes, held O.K. Tested BOPs 250# low and 200# high for 10 minutes each. Tagged cement @ 2865'. Rig up mud loggers and drill with 6 1/4" bit, open hole 2865' to 3375'. 11/7/05 Ran 5 1/2" liner, top @ 2856', bottom @ 3370'. No cement or pressure testing required on 5 1/2" liner.
