

10/29/05 Spud well. 10/30/05 Drilled 12 1/4" hole to 204', ran 9 5/8", 36#, J-55 STC casing, landed @ 191.64' KB (KB=5.0'). On 10/30/05 Cemented with 151 sks Type III cement plus 3% CaCl, plus 0.25 lb/sk Celloflake, yield 1.38, 208.38 cu. ft. We ran centralizers on all joints. Circulated 13 BBLs good cement to surface. Wait on Cement 12 hours. Tested BOPs 250# low and 2000# high for 10 minutes each. Tested 9 5/8" casing to 600# for 30 minutes, held O.K. Tagged cement @ 130'.
